

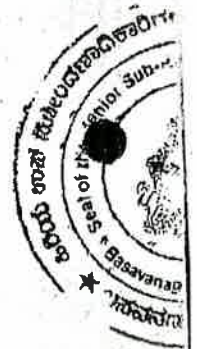

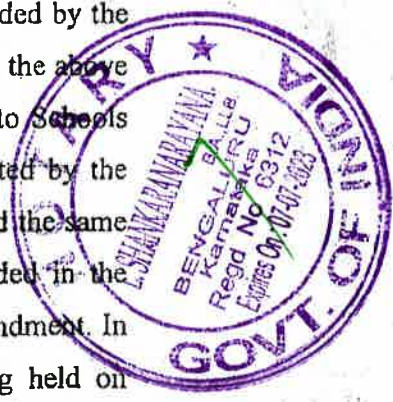

Whereas, after coming into force of "Arka Educational and Cultural Trust" considerable progress has been achieved by the Trust headed by the present four trustees including the Author of the Trust. R. Chandra Jain, the Author of the Trust and now Managing Trustee of the Trust and other three Trustees of the Trust mentioned above to execute this Deed of Amendment of Trust.




